


The complete set of all twelve parts, extremely rare. Third edition of both the first two Collections, second edition of the third Collection, and first editions of the remaining nine Collections. Included is the rare and important *Narrative of the miseries of New England by reason of an arbitrary government erected there* (in part VI) by Increase Mather which "relates to the attempt to take away from the New England colonies by Quo Warranto and other proceedings the 'ancient Rights and Priviledges' which they had enjoyed under their charters." An additional pamphlet, *An address of the dissenting ministers*, written by ministers opposed to William and Mary's accession to the throne, is bound in. \$ 8500.00


First edition under this title (expanded from the 1606 printing *A true and perfect relation of the proceedings at the severall arraignmentes of the late most barbarous traitors*). This is a detailed account of the events leading up to and following the Gunpowder Plot, a failed assassination attempt on King James I. A group of provincial Catholics led by Robert Catesby and Guy Fawkes plotted to bomb the House of the Lords on November 5 in order to promote James's daughter Elizabeth as a Catholic monarch. \$ 650.00


First edition. Beaudry was a chaplain for the 5th NY Volunteer Cavalry and a prisoner at Libby where each week the prisoners would compile the "newspaper." Beaudry, who was the first editor and reader, retained the original manuscripts and published these seven issues for the first time here. Richmond's Libby Prison was used to hold Union officers during the war. Notorious for the poor sanitation and crowded conditions, many prisoners lost their lives while incarcerated there. \$ 500.00

Second edition, corrected by Dr. Samuel Beaumont, the author's cousin. First published at Plattsburgh in 1833 in 3000 copies, this landmark work recounts Beaumont's brilliant clinical investigation into the physiology of digestion. His patient, who had received a near mortal gunshot wound to his abdomen and chest, recuperated over a period of many months, sustaining a permanent fistula in the stomach wall through which Beaumont was able to undertake his study of the process of digestion. This second edition, published in 1500 copies, is quite scarce. \$ 700.00





First edition of one of the most important and beautiful works of conchology. In 1776, Maria-Therese, Empress of the Holy Roman Empire, commissioned Born to inventory and arrange the immense imperial collection which was the foundation of the imperial museum in Vienna, now the Naturhistorisches Museum. This volume on shells was the only one published due to Maria-Therese's death in 1780. The engraved plates are exquisitely hand-colored; the text provides equally detailed descriptions of the hundreds of species in the collection.

Probable second American edition. This novel "relates the development into manhood of a sensitive, trusting boy beset from every side with crushing difficulties." It was made into a motion picture in 1946 and starred Charles Coburn, Tom Drake, Hume Cronyn, Dean Stockwell, Jessica Tandy, Richard Haydn, Wallace Ford, and Selena Royle, all of whom signed the front fly-leaf (amongst many other actors from the film). The book is a compendium of illuminated borders in manuscripts, mainly from the Middle Ages but also comprising some Renaissance and Islamic examples. The appendix, published in 1858, contains additional information about the manuscripts including a bibliography and catalogue. The book is truly an outstanding achievement of the technology, as the majority of the borders were executed in ten or more colors requiring over 900 stones. \$ 3000.00

12. **DARWIN, Charles.** *On the origin of species by means of natural selection or the preservation of favoured races in the struggle for life.* New York: D. Appleton and Company, 1860. 8vo. Original brown blind-stamped publisher's cloth.

First American edition. This, the fourth issue, with the added three quotes, is the first of the American (and all other) issues where the text has been considerably altered, revised and augmented by the author. It contains the historical sketch in its earlier and shorter form as a preface, and a supplement of seven pages at the end. \$ 8500.00

ARCHIVE FROM ONE OF THE MOST FAMOUS WOMAN
EXPLORERS OF HER TIME

13. DAVID-NÉEL, Alexandra (1868-1969). Small archive, consisting of 3 manuscript letters, all signed by David-Néel; manuscript in her hand of 4 pages; two (2) typescripts. All material dated no later than 23 November 1924.

French explorer and author Alexandra David-Néel, a scholar of Buddhism and Eastern religions, was the first Western woman ever to visit the holy city of Lhasa, the center of Tibetan Buddhism. As a teen, she studied Eastern religion and the occult with the Theosophical Society of Madame Blavatsky. After learning Sanskrit and Tibetan she traveled through Ceylon and India, where she was introduced to the thirteenth Dalai Lama (1876-1933), born Thubten Gyatso, who had recently fled Tibet. David-Néel was able to ask and receive answers to several questions on spiritual enlightenment from the Dalai Lama, which is believed to have made her the first white woman ever to address the leader of Tibetan Buddhism on such topics. She went on to the royal monastery in the nearby kingdom of Sikkim, where she met the crown prince, Sidkeong Tulku Namghyal, who would ascend to the throne in 1914 (there were rumors the two were romantically involved). She later journeyed to Lhasa and across China to a famous monastery called Kum-Bum, considered the birthplace of Tibetan Buddhism, where she translated Tibetan sacred texts into French. The letters in this archive are written to Boshi Sen (1887-1971), a famous Indian agriculturalist and scientist who was instrumental in creating a means to grow massive amounts of grain for the purpose of reducing famine in India, who was in America at the time. She mentions her friend Prof. [Nicholas] Roerich (1874-1947), a Russian who was twice nominated for the Nobel Peace Prize. David-Néel returned to France in the spring of 1925. Her magazine articles were finally published and ultimately became sensational books that were translated into English as well as other languages.

Thirteen years of travels in Eastern Solitudes

In the year 1910, I was commissioned by the French Ministry of Public Instruction to go to the East for Orientalist researches. So, I sailed from Marseille, greatly rejoicing to pay a new visit to countries of which I had been dreaming since my childhood and to be able to gratify the unsated curiosity that a previous journey had left in me, but, although some strange inexplicable feeling seemed to presage unexpected developments to my travel, I was far from foreseeing towards what extraordinary adventure I was led.

After a rather long stay in Ceylon and in India, in early spring 1912, I learn that the Dalai Lama, the ruler of Tibet, who had fled from his country was living at Kalimpong, a village in the lower Himalayas. In my youth, as a pupil of Prof. Foucaux of the "College de France", I had become acquainted with Tibetan literature so that, circumstances having brought me at easy reach of him, I wished to meet the pope of the Lamaist creed. It was not easy, told me the British political agent for Tibet, because the Dalai Lama had, till then obstinately refused to receive foreign ladies. But I had well managed the things, I produced pressing letters of introduction from high personalities of the Buddhist world and the conclusion was that the Dalai Lama's desire to see me grew even stronger than mine.



With 49 full-page chromolithograph reproductions of miniatures, remaining text leaves with half-page chromolithograph borders, text with printed rubrications and ruling. Red morocco with gilt lettering on spine, first volume with the gold-tooled and embossed coat-of-arms of Anne, Duchess of Brittany. In absolutely exquisite condition.

Rare complete facsimile and translation of what has been described as “one of the magnificent Books of Hours ever made.” The *Grandes Heures* belonged to Anne, Duchess of Brittany (1477-1514), who served as Queen consort to two successive kings of France, Charles VIII and Louis XII. Now at the Pierpont Morgan Library, the original work was created between 1492 and 1495. The illustrations presented an immense technical challenge for creating this reproduction. Curmer states that the stones (likely up to 4,500) would be effaced after the 850 copies were printed making this the only edition available. The second volume consists of a list of subscribers (first among them Napoleon III), a notice to the reader, and text of the manuscript. \$ 25,000.00

First edition of this fascinating work on Native American life in the mid-west. The author initially discusses the various tribes and notes their feelings toward the non-native Americans. He explains many of the social aspects of Native American life, including marriage, religion and government, as well as detailing the relationships with the French and English settlers. Dodge also provide examples of the language of each tribe. The remainder of the work treats accounts of the captivities of Daniel Boone, Simon Kenton, Colonel James Smith, and others. \$ 2500.00

Second edition. Having enjoyed a successful career as a novelist in England, Edwards traveled independently to Egypt without a male chaperone and in the company of a lady friend, where she became fascinated with Egyptology and archaeology. This second edition corrects "some of the historical notes by the light of later discoveries," but the narrative remains untouched. While much of the text recounts her delightful and often intrepid excursions in Egypt, Edwards was also keenly observant of her environment, commenting on the ethical implications of excavation, the antiquity trade, and colonial exploitation. \$ 550.00

A large, wide-margined copy of the 1546 Herwagen edition of Euclid. It contains an explanation of all books, plus the *Phaenomena*, *Catoptrica*, and *Data*, as well as the first printing of the *Opusculum de Levi & Ponderoso*, a fragment of which was discovered just as the present work's first edition was about to be printed. \$ 10,500.00

SUCCESS OF THE PARLIAMENTARY ARMY

Rare first edition. Fairfax was a commander in the Parliamentary army during the English Civil War. He was responsible for many victories against Royalist forces under Charles I, including the sieges of Hull and Selby. This pamphlet recounts Fairfax and his son's success at Selby on April 11, 1644. The Royalists fortified the town with barricades and the flooding of the dam fields. The Fairfaxes (Lord Fairfax and his son Sir Thomas Fairfax), attacking from three directions at once, secured victory with ease. With the fall of the town huge stocks of munitions and more than 1,500 Royalist soldiers were lost to the Parliamentarians. The road from Hull to York was now opened for a Parliamentary advance on York, which they were able to besiege.



First edition. Fox had initially intended to treat events past the year 1688 in order to compare the virtues of William III with the failures of James II. But he never completed the text so the work ends at 1685. For him James's reign represented a core issue within English culture and politics. His history of England here reflects an ongoing struggle between the absolutist intentions of monarchs and the struggle of their subjects to assert their individual liberty. Fox's incisive analysis along with a detailed appendix of correspondence between Louis XIV and M. Barillon on English affairs as well as between the Earl of Sunderland and the Bishop of Oxford continues to be an important resource for historians.




THE FOUNDATION OF PHRENOLOGY

First edition in English, the very rare complete set. These volumes were translated from the revised second edition of Gall and Spurzheim's *Anatomie et Physiologie du Systeme Nerveux*, which "introduced the theory of localization of cerebral function." "This pioneer attempt to map out the cerebral cortex according to function gave rise to the pseudo-science of phrenology. The work also contains some important additions to the knowledge of cerebral anatomy" (G&M). Of particular interest is Gall's attempt to reconcile moral qualities and intellectual faculties with human behavior.



First edition of Gould's monograph on the Pittidæ family of birds. Located in the tropical and subtropical regions of Asia, Indonesia, and Australia, the Pittidæ are a type of brightly colored insectivorous thrush. Beautifully hand-colored lithographs render the vibrancy of the birds' plumage, and Gould's text provides thorough and meticulous descriptions of the ten species represented in the monograph. A second part consisting of text only was also later published. \$ 12,500.00

23. GREENOUGH, George B. *A critical examination of the first principles of geology.* London: Longman, Hurst, Rees, Orme, and Brown, 1819. 8vo. Modern calf and marbled boards.

First edition. This is the only independent work written by Greenough and consists of a series of essays critical of the plutonists. Greenough came under the influence of Blumenbach and devoted himself to the study of natural history. Elected a Fellow of the Royal Society, he later founded the Geological Society of London, the Royal Geographical Society, and the British Science Association. \$ 550.00



First edition in English from the French of 1851 of this detailed history of the Waldensians, the pre-Protestant Christian movement founded in the late twelfth century whose focus was renouncing wealth and property and valuing poverty. Over the centuries the Waldensians clashed with the Roman Catholic Church and were nearly wiped out in the seventeenth century. Today the church continues to be active especially around the area of Piedmont in Italy. This work is bound after the **first edition** of Headley's account of his travels around Italy. \$ 550.00


This is the famous group of ten stories of children who are not good, do not listen to their parents, and therefore suffer the results, often drastic consequences, of their cruel mischief. Each of these stories has been related to psychiatric conditions. \$ 350.00



RARE INTERIM PHILOSOPHICAL TRANSACTIONS

26. [HOOKE, Robert, ed.] *Philosophical collections, containing an account of the physical; anatomical, chymical, mechanical, astronomical, optical, or other mathematical and philosophical experiments and observations as have lately come to the publisher hands. . . .* London: [John Martyn], Moses Pitt, and Richard Chiswell, 1679-82. First edition of the complete run of the *Philosophical collections*, printed in a very small edition, and now exceptionally rare. The 1677 death of the Royal Society's secretary, Henry Oldenburg, interrupted publication of the *Philosophical transactions*. This journal, edited by Hooke, was issued to fill the void until it resumed again in 1682. 

The Society takes issue with Mr. Birkbeck and his settlement on the “fever prairies” of Illinois as well as discouraging any trans-Allegheny colonies. He felt threatened by the Puritan movement and was intolerant towards Presbyterians. The Long Parliament of 1640 accused him of treason, resulting in his imprisonment in the Tower of London where he remained throughout the early stages of the Civil War. In 1644 he was brought to trial which ended without a verdict. Parliament took up the issue, and eventually passed a bill of attainder under which he was beheaded on January 10, 1645, notwithstanding being granted a royal pardon.

Ludlow scathingly characterizes Hollingworth’s pamphlets as “pieces of flattery compiled by a hungry Levite, gaping at a deanery or chaplainship at Whitehall.” To add insult to injury, he amplifies his attack on the monarchy by including a critique of Charles II. Although the medieval town was small and sparsely populated, it represented a significant strategic point during the Wars of Religion because it had an imposing fortress and was located along the Santiago de Compostela pilgrimage route. Thus, it became an important locale for the Inquisition, and in 1562 was the site of a Protestant massacre of 200 people.





He treats various crops such as wheat, vegetables, cotton, and tobacco, timber, soil management, and the raising of sheep and cattle. He also provides instruction as to brewing and malting, including cost of ingredients and prices of finished products. He further opines on slavery, religion and transportation as related to agriculture. 

Many of the decrees deal with the settlement or reconstitution of estates that Cromwell's supporters lost during the English Civil War. The printer Hills, after imprisonment for adultery and known for his Leveller pamphlets, became a confidant of Cromwell, and along with John Field obtained the sole privilege to print English bibles and psalms, much to the consternation of the former King's printers. Hills continued to navigate the ever-changing political terrain after the death of Cromwell and the Restoration, becoming the master of the Stationers' Company. Pritcher presents an impassioned argument for free universal health care, contraception, no-fault divorce, social clubs, collective childcare facilities, and comprehensive applied sex education. This healthy, community-regulated sexual pedagogy is apparently the author's cure for any number of societal ills, including venereal disease, mental health issues, child abandonment, impotence, marital violence, gender inequality, infidelity and all manners of sexual perversions allegedly born of ignorance. Our narrator is quick to describe the sad and unhealthy sexual practices of the Adamites (the people of Earth) to the Amorites, his hosts, who do not ask him for the explicit details but have to listen to them anyway. Presumably for this reason the book was once held in the Delta Collection of the Library of Congress with other materials classified as pornographic, obscene or otherwise restricted. The text combines both progressive and extremely regressive ideals to paint a picture of a 1930's America filled with "despotic, scheming, plotting female tyrants, all of the ice box variety" and an urban landscape where two young women may find "perfect sex satisfaction and happiness" with one another, because "in the large centers, such sex perverts find enough of their kind to live in a world apart from normal human beings." This work is cited in Sargent's bibliography of Utopina Literature in English as *A love starved world* with identical biographical data. Along with the Earl of Bedford, John Pym, and John Hamden, he formed a reformist yet moderate coalition known as the “middle group.” As Solicitor General, St. John led the impeachment and attainder against Thomas Wentworth, Earl of Strafford. St.

John’s famous speech to Parliament is here transcribed and enlarged. In an especially vitriolic passage, he described Parliament as “both the physician and the patient” saying that if the government had any corrupt member, like poison or gangrene, then the government had the power to “cut it off for the preservation of the rest.” In addition to evocative metaphors, St. John built on his earlier arguments concerning the hated ship-tax that Charles I imposed in the late 1630s. By the end of the attainder, he had successfully charged Wentworth of treason and removed him from Parliament. This was a serious blow to the monarchy as the Earl was one of the king’s most trusted advisors.

The Church of England adopted Ussher's dates for use in all official Bibles in 1701, and thus his calculations came to be regarded with almost as much unquestioning reverence as the Bible itself. It provided a key point in the high drama of the Scopes trial; when Clarence Darrow examined William Jennings Bryan, he chose to focus primarily on a chronology of Biblical events, and frequently discussed Ussher's calculations. Though Bryan stood fast with the Bible's (thus Ussher's) position on the date of creation, he broke faith with

the most faithful Fundamentalists when he testified that he did not believe that the Genesis statement of six days to create the Earth meant literal 24-hour periods. This set up the current split in the Fundamentalist evangelical community.



A raging success, this particular work exposed westerners to Eastern culture, religion, landscape, and customs and was the definitive work on the East for many years.

In July 1641, soon after the Long Parliament was called into session, Waller spoke to both Houses calling for caution and class solidarity among his colleagues and constitutional moderation. He specifically discusses the impending (and ultimate) impeachment of a Royalist judge, Sir Francis Crawley, who argued that Charles's implementation of taxes on ships was within the right of the king. Waller, even though he supported the king, came out against the impeached judge stating that "he did ... give as deepe a wound to the Commonwealth as any of the rest." Waller was eventually exiled for his role in the so-called "Waller's Plot" that began as an act of passive resistance among the citizens of London but soon developed into a violent plan to raise an army for Charles I within the city. \$ 700.00



A gift from Dr. James T. Wayson to Dr. William Howard Dudley, this photo album chronicles the effects and treatment of lepers at the Kalaupapa Colony. In 1865, laws went into effect to allow the arrest and removal of those diagnosed with leprosy in order to stifle the spread of the disease, for which there was no known cure. Kalaupapa began receiving patients in 1866 and continued until the isolation laws were lifted in 1969. Most of the patients living in the colony chose to stay, though, and some are still there today. The colony also served as an experimental ward for treatment of different kinds of leprosy. The photographs document lesions and sores on the patients' bodies as well as surgical wounds and amputations. Of the men and women in the photographs, only the non-native Hawaiians are labeled in any way: four "Chinamen" and one "German". 


Later edition. The first printing, without Scripture texts, was issued in 1647, with a second edition (of 600 copies) printed in London later that same year under the same title "with the Quotations and Texts of Scripture annexed." After the reforms of the sixteenth century, the Scots Confession served as the primary confession for the Church of Scotland for just over eighty years. In 1648 it was replaced by the Westminster Confession of Faith and is still used today in many Protestant denominations. The project of the assembly at Westminster was to create a unified religious settlement for the three kingdoms (England, Scotland, Ireland) incorporating reformed doctrine, polity, procedure for worship, psalm and prayer texts, and relationship with the civil order. The Westminster document is more explicit about doctrine than the earlier Scots Confession, and regulation of the ministry of word and sacrament is excluded from the responsibility of the civil magistrate. Parliament adopted the Confession in full in 1647. A 1648 London edition represents the Parliament's officially adopted version. After the adoption, innumerable editions appeared under the proper title Confession of Faith. Smaller editions of the London and Edinburgh printings were issued in 1648 and 1650, respectively. 


CHARLES BETRAYED BY SCOTLAND!

First edition. At the behest of Charles I, Windebank wrote this summary of the Bishops' War after the King agreed to the Treaty of Berwick, which was signed on June 19, 1639. Charles' brief campaigns against the Scots, first in 1639 and then again in 1640, were the result of his efforts to enforce Anglican ideals in the Scottish Church. The Scots, for their part, were equally opposed to episcopacy. Despite wishing to march on Scotland, Charles did not have sufficient funds or troops and instead signed the Pacification of Berwick. However, Charles discovered that the Scots were plotting with France, and called Parliament into session in April, 1640. Windebank's pamphlet, essentially a mouthpiece for the King, expressed the monarch's anger, highlighting the perceived betrayal on the part of the Scots and providing a justification for calling the Parliamentary session. The "Short Parliament" as it was called was quickly dissolved for not supporting Charles' campaign. \$ 1500.00
